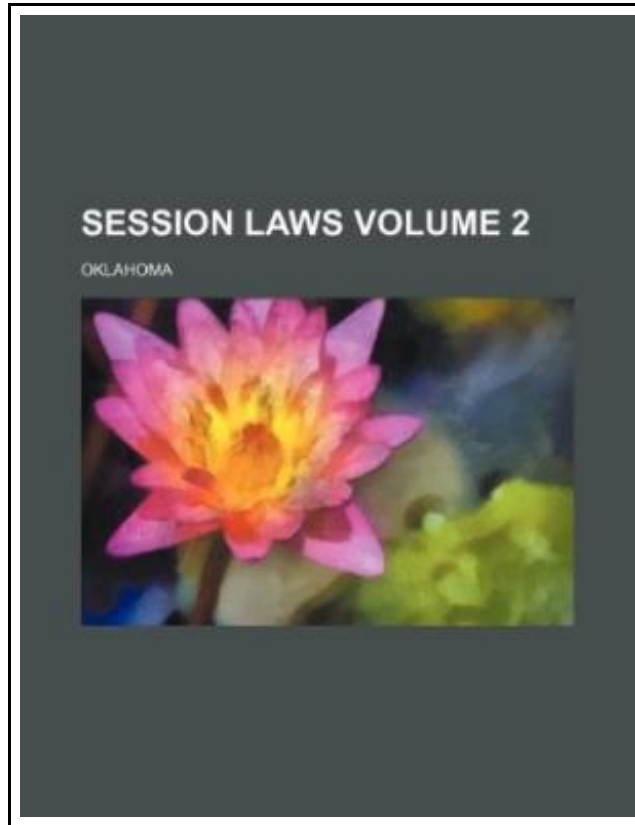

If any person feels aggrieved at the action of the county surveyor in establishing such line, he may appeal to the district court of the county in which the land is situated, as provided in Section 5 of this Act, and all proceedings thereafter may be as hereinbefore pro-vided.
