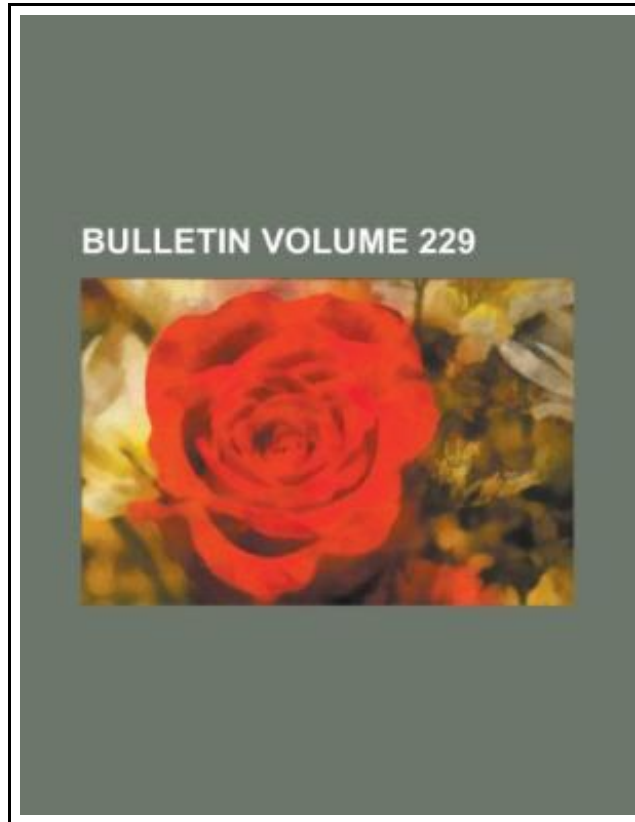

OMB First, OMB Bulletin No. 01-02, Audit Requirements for Federal Financial Statements, dated October 16, 2000, prescribes specific language auditors should use when reporting on an agency systems substantial compliance with FFMA. Specifically, this guidance calls for auditors to provide negative assurance when reporting on an agency systems FFMA compliance. Second, in a January 4, 2001, Memorandum, Revised Implementation Guidance for the Federal Financial Management Improvement Act, OMB provided guidance for agencies and auditors to use in assessing substantial compliance. The guidance describes the factors that should be considered in determining an agencys systems compliance with FFMA. In addition, examples are provided in the guidance as to the types of indicators that should be used as a basis in assessing whether an agencys systems are in substantial compliance with each of the three FFMA requirements.
